On behalf of the CITF, I would like to welcome you to the Construction Health and Safety Technician (CHST) Exam Prep workshop. We are thrilled to have you join us again for an engaging, highly demanding, and fun-filled week.

As you prepare for the CHST Exam, you must complete and submit some documents to the Carpenters International Training Fund (CITF) and the Board of Certified Safety Professionals (BCSP). The first document is the CHST information Gathering Form. The second document is a copy of your Safety Trained Supervisor Construction Certificate. This can be found by logging into your BCSP profile and downloading it. Both must be submitted to the local training center to register for the class. Once registered for the class, you **MUST** complete and submit your CHST application to the BCSP.

Your CHST application **is subject to a strict deadline. It MUST BE RECEIVED by the BCSP 31 days before the start of the class. Failure to meet this deadline will result in your registration being canceled.** We strongly urge you to submit your application on time to secure your spot in the workshop.

Around 45 days from the workshop start, you will receive an email from a representative from the BCSP. This representative will be able to assist you and answer any questions that may arise.

Your study guide, along with directions for the class prework, will be mailed to the address provided. If you have moved and have a new address, please ensure to submit a new BCSP Information Gathering Form with your updated address. Please note we **will not be mailing out additional study materials.**

If you have any questions, please direct them to your local training center. They can assist you.

They should also inform their local training center beforehand when submitting the BCSP information gathering form.

All participants in this course must agree to have their BCSP account and application completed and submitted 31 days before their scheduled class starts. Failure to complete this will result in the attendee's registration being canceled. Canceled registrations will not be reinstated. The attendee will have to register for the next available course.

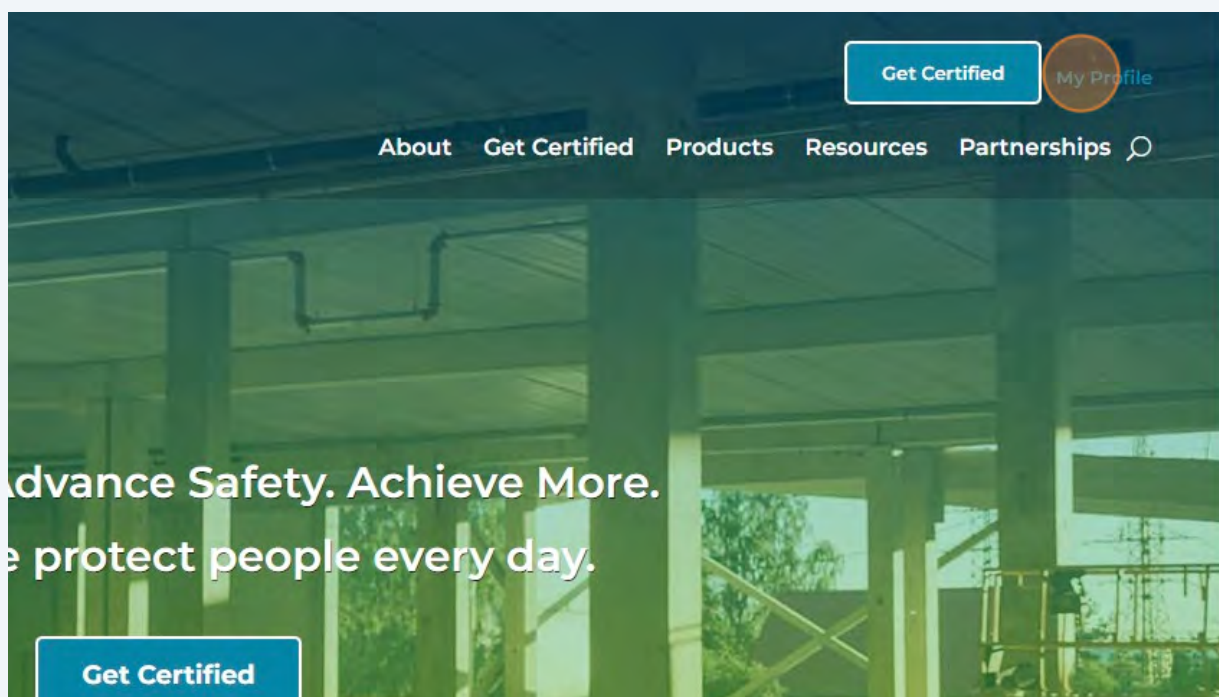

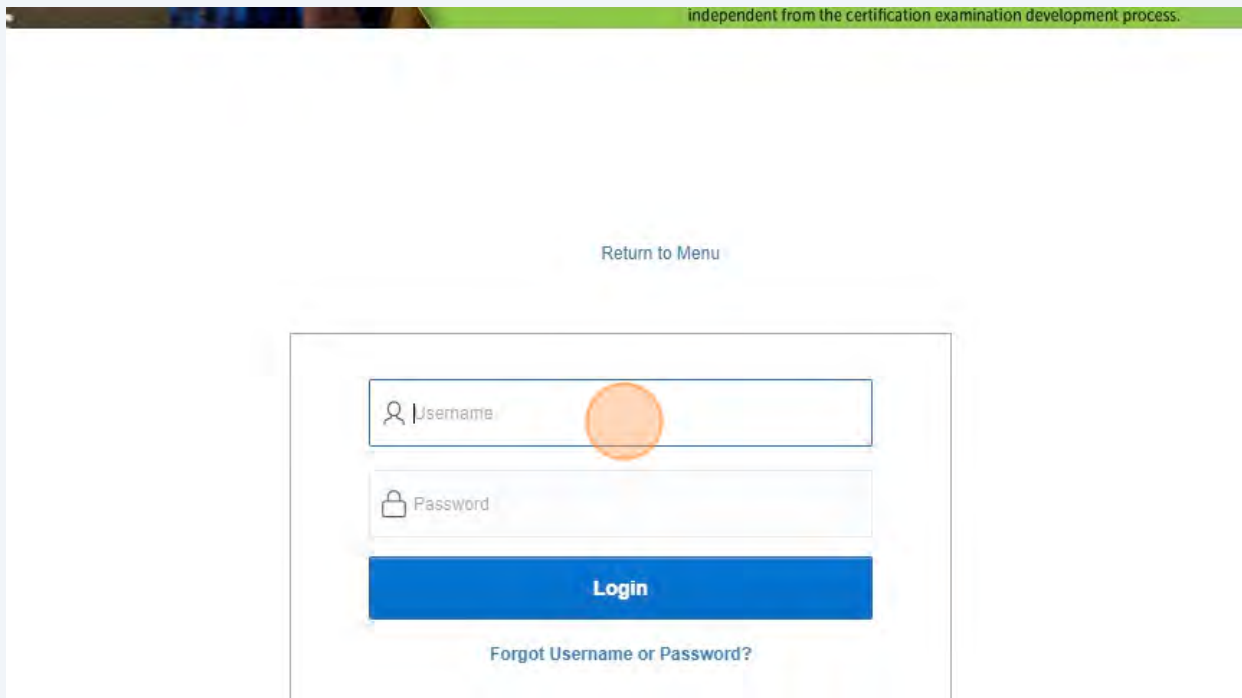

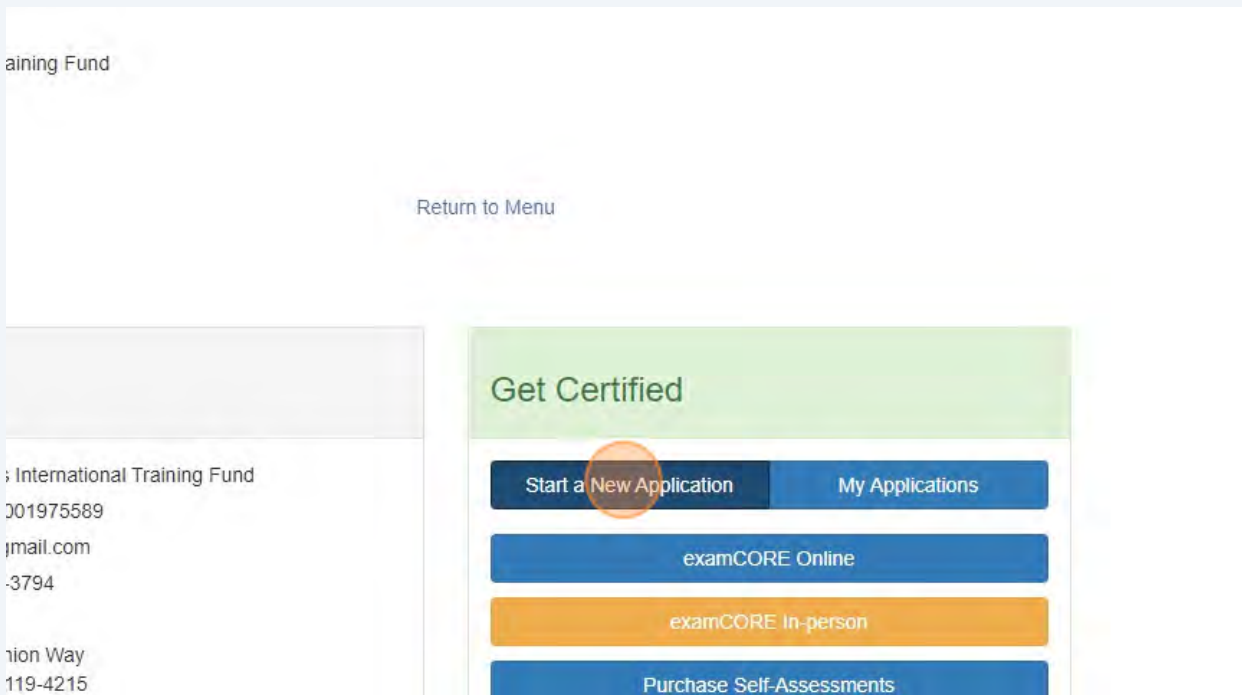

Overlapping months will not receive double credit.

For applications that are selected for audit, acceptable forms of validation documentation for work experience include:

1. A copy of the Experience Form(s) submitted with your application signed by supervisor
2. A letter on company letterhead from employer validating employment dates, job title and duties, and whether the work was Safety/Health/Environmental;
3. BCSP Experience Validation Form completed by employer (ONLY IF YOUR APPLICATION IS SELECTED FOR AUDIT)





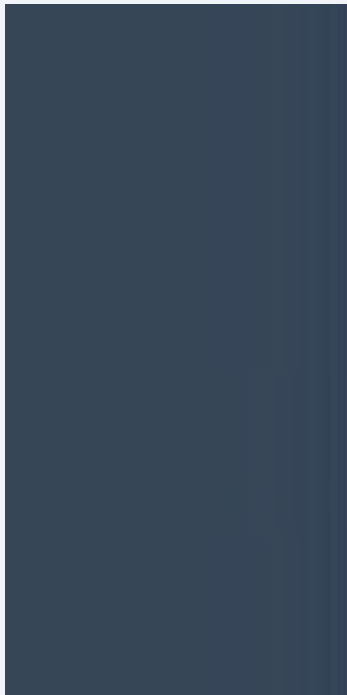
